IMPORTANT CAMP POLICIES



TRANSPORTATION

Campers will be transported to and from camp in whichever type of vehicle the director determines is best suited to effectively serve the particular location - taking into consideration the number of families to be serviced, travel time to camp, and availability of transportation in that particular area. **Please understand that it is virtually impossible to honor transportation requests.**

EXTENDED HOURS CHARGE

Campers who use the extended hours program in the A.M. ONLY or in the P.M. ONLY will be charged \$150.00 per camper for the season; since the camp must provide a ride either to or from the camp and the extended hours supervision for that child. Campers who use the extended hours program both in the A.M. and P.M. **WILL NOT** receive an additional charge.

GROUP PLACEMENT

All requests must be made in writing on the application form. Requests by families of full season campers for specific grouping cannot be honored after April 15th. Where age differences are too great or not appropriate or if a group is complete, it may not be possible to honor the request. Requests are honored for only up to two campers in a group. **Half season campers** will be grouped based upon availability of space in bunks. **Do not assume that the same grouping will occur as the previous year.**

TUITION

An early season rate reduction can be earned if a \$200 deposit is made at the time of enrollment and an additional \$300 is deposited on or before December 31st, 2010 with the **BALANCE PAID IN FULL BY MAY 1st, 2011.** Deposits and balances paid thereafter **DO NOT EARN THE RATE REDUCTION.** Only one discount may be used per camper when applicable. All fees are to be fully paid by May 1st, 2010. All fees with the exception of \$50.00 per camper are fully refundable until April 30th. From May 1st until the beginning of camp, all fees are refundable with the exception of the \$200.00 deposit per camper. If you choose to extend your camper's enrollment after the beginning of the camp season, an additional \$25 enrollment adjustment fee will be charged.

CAMP ADJUSTMENT POLICY

In case of withdrawal of a full season camper during the first and second week of camp, 50% of the fee is refundable; if a camper withdraws during the third or fourth week, 25% is refundable. ***No refund shall be made for any subsequent withdrawal once the season begins, no refunds will be made for half season campers. No substitution will be made for any enrolled camper.***

CAMPER RESPONSIBILITY:

Camp is not responsible for campers' personal belongings or equipment while in transit, or in use at camp, if lost or damaged by fire, water, theft, etc. The following items are **NOT to be brought to camp:** Cell phones, video games, radios, cameras or any other valuables.

PARENTS CONCERNS:

We care a great deal about each camper as an individual, but we do need your help. Should you become even slightly concerned over something that happened involving your youngster, please call! We want to know, we want to help, and we do know how. We cannot address problems that are not brought to our attention. For us, camping is a 12-month effort - 10 months for planning, building, buying and staffing, and two months, July and August, for helping kids to have a really **happy and fruitful experience.** Help us - **PLEASE.** By the way, we also just love to hear about the great things our people do.
